They suggested she gather more specific information and bring it to the September HARB meeting. Examples of such information were: a photo and/or drawing of the actual proposed shed design, exact colors including manufacturer names, and any additional details possible.

## John & Evelyn Bertinatti • 1013 Radley Drive

Mr. and Mrs. Bertinatti attended tonight's meeting requesting approval to remove their home's stucco and cedar siding. They plan to replace it with Everlast siding and trim. The siding will be  $6 \frac{7}{8}$ " in the shade Chestnut, and trim will be in the color Natural White. The windows will remain the same and be trimmed in the Everlast Natural White color. The soffits will be white and the downspouts will be in a shade that is similar to the Chestnut siding. The front door will remain the same red shade, and the sidelight panels can be in a matching red or white, with white trim. The wood garage doors and trim will be painted to either match the red front door or white. There's also a vent at the top of the garage that will be white. Ms. McCarthy motioned to approve the Bertinatti's proposed changes. Mr. Campbell seconded. All in favor.

Ms. McCarthy motioned to adjourn the meeting. Mr. Campbell seconded; All in favor. With no further business, the meeting was adjourned at 7:44 PM.
