## DILWORTHTOWN INN COMPLEX DRIVEWAY ALTERATIONS

Mr. Frank Rupp, Owner of Dilworthtown Inn properties, Mr. Jose Grande, Engineer at Yerkes Associates and Bryan Rogers, tenant of 225 Brintons Bridge Road AKA Rooney's at Dilworthtown were present tonight to discuss the HARB application for driveway alterations. The purpose of adding a new section of driveway is to connect 225 Brintons Bridge Road to the rest of the existing campus. Ms. McCarthy noted that any driveway updates such as paving and parking spaces would be considered a zoning or planning commission topic, therefore decided to change the proposed project on the application to reflect only needing approval from HARB for the exterior light fixtures.

The proposed lamp posts would be replicas of the ones that are already existing on site. The exact name is Chatham 2 Light Outdoor Post Lantern by Generation Lighting, made of brass in the color Weathered Copper, 8'9" in height. The posts will consist of unfinished wood.

Not HARB related, Mr. DiMartini suggested contacting the fire company to ensure that the new driveway is of adequate size to handle the turning of a fire apparatus in case of emergency.

Mr. Campbell motioned to approve the Chatham 2 Light Outdoor Post Lantern in Weathered Copper with unfinished wood posts which will be made to replicate the existing lights already on the property. Mr. Nash seconded; all in favor.

#### There was no public comment.

With no further business, Mr. Garrison motioned to adjourn the meeting. Mr. Nash seconded; all in favor. The HARB meeting was adjourned at 7:42 PM.
