#### **APPROVAL OF MINUTES**

#### **Brandywine Creek Greenway**

The Brandywine Conservancy would like to add Birmingham Township to its Brandywine Creek Greenway initiative, which involves 27 municipal partners in Delaware and Chester counties. According to [Brandywine.org](http://Brandywine.org), "The vision is to create a 40-mile long conservation and recreation corridor along both branches of the Brandywine that stretches from the Christina River in the City of Wilmington to the Pennsylvania Highlands in Honey Brook Township." Mr. Feld plans to attend the meeting this week to discuss the project on behalf of RPOS, as he believes the Committee at its current capacity would not be able to handle this new undertaking.

## **Birmingham Hill Trail**

### **Fence Posts**

There are currently several broken rails that must be replaced and tree roots that need to be removed on the trail. Mr. Feld, Ms. O'Neill and Mr. Bonkoski agreed on May 14th as a tentative work day. Mr. Feld plans to reach out to Ms. Brecker and Mr. Socash to see if they will be available that day.

### **Stop Sign**

As a follow up regarding last month's stop sign discussion, Mr. Feld informed Chief Nelling about it as it's a Township road issue.

## **Sandy Hollow**

### **Mowing**

Last Friday, Sandy Hollow had its first mowing of the year.

### **Pipe Under Trail**

The hollow at the bottom of the hill will require repair as it pools ice in freezing temperatures. Chief Nelling informed Mr. Feld that he will put the project into his upcoming budget.

### **Milkweed**

Mr. Feld received a call from a Knolls resident regarding preserving the milkweed this year, so he plans to call Jamie Hicks to discuss the mowing. However, most of the fields will eventually need to be cut due to the Reenactment.
