Flags

Sandy Hollow Update

Mr. Feld recently looked at the cannon and feels that it will need to be touched up this Fall. The black is Black Rustoleum and the gray is Benjamin Moore Silver Spring and there may be some in the Township closet.

Mr. Feld reached out to Mr. Hicks to ask that he not cut down the milkweed. Unfortunately, it was too late and it had already been cut down.

A resident called the Township and stated that there is poisonous wild hemlock growing along the trail. Mr. Hicks was able to mow most of it down and Mr. Feld sprayed what was left of it. While there, Mr. Feld noticed that Sunny Gardens is not trimming the trail well enough and there are cracks with high weeds that could be tripping hazards. Mr. Feld was able to spray them for now and also called Sunny Gardens to let them know.

There was a meeting regarding the Reenactment last week. They plan to launch a website advertising it soon. A total of forty volunteers are needed, and the Historical Committee will man the tent along with RPOS.
