BIRMINGHAM TOWNSHIP BOARD OF SUPERVISORS MINUTES MAY 1, 2017

STOLTZFUS CONDITIONAL USE HEARING

A hearing to consider the conditional use application of Earl Stoltzfus, Stoltzfus RV, to develop a new and used motor vehicle sales agency, including customer service and repair, at 1345 Wilmington Pike was held prior to the regular meeting. The hearing was transcribed by Court Reporter Colleen Pimer. The Stoltzfus RV business is located at 1335 Wilmington Pike. Mr. Stoltzfus is looking to use the adjacent Brandywine Patio property for RV sales and repair facilities.

REGULAR MEETING

The regular meeting of the Board of Supervisors was called to order at 7:31 PM by Chairman Conklin with the pledge of allegiance. A quorum of Supervisors was declared.

Scott Boorse - Vice-Chairman
Mike Shiring - Supervisor

Chairman Conklin moved to approve the April 3, 2017 minutes as written. Vice-Chairman Boorse seconded the motion and the minutes were approved. Supervisor Shiring abstained from voting as he did not attend the meeting.

Vice-Chairman Boorse moved to approve the bills submitted for payment. General Fund bills totaled \$43,133.07. Sewer Fund bills totaled \$24,986.77. Supervisor Shiring seconded the motion and the bills were unanimously approved.

RADLEY RUN COUNTRY CLUB ROAD CLOSURE REQUEST

Joe Mendez, Manager, Radley Run Country Club (RRCC), was present to request permission to close Country Club Road on Saturday, August 26th from 5 PM – 2 AM for a charity fund raiser for the Chester County Food Bank. The road would be closed from General Lafayette Blvd. to Creek Road. Since requesting to be on the agenda, Mr. Mendez has talked to Chief Nelling who indicated that there could be an access problem for the residents west on Country Club Road, Hessian Circle, and General Wayne Drive, as well as for emergency response vehicles, if Creek Road is also closed because of the Rt. 926 bridge construction project. Mr. Mendez understands that the request is contingent upon Creek Road being open. At this time no action was taken by the Board as those involved in the fund raising event will regroup and decide whether to proceed or not with the event at the RRCC.

HARB REPORT

HARB met on April 18th to consider three applications.

504 DILWORTH FARM LANE/KERSHAW/ROOF

HARB recommended that a Certificate of Appropriateness be issued to Jim and Erin Kershaw, 504 Dilworth Farm Lane, for a roof replacement with Certainteed Landmark Pro designed

shingles, color Max Def Driftwood. Chairman Conklin moved to approve the Certificate of Appropriateness as recommended by HARB. Vice-Chairman Boorse seconded the motion and it was unanimously approved.

1010 REVOLUTIONARY DRIVE/KOZELKA/PAINTING

HARB recommended that a Certificate of Appropriateness be issued to Thomas Kozelka, 1010 Revolutionary Drive, for painting the brick, siding and shutters on his house. The paint will be Benjamin Moore, color dove wing, for the house and trim and the shutters will be Ashley gray. Supervisor Shiring moved to approve the Certificate of Appropriateness as recommended by HARB. Vice-Chairman Boorse seconded the motion which was approved all in favor.

1014 REVOLUTIONARY DRIVE/MCCLASKEY/ROOF

HARB recommended that a Certificate of Appropriateness be issued to Judy McClaskey, 1014 Revolutionary Drive, for a roof replacement with Certainteed Grand Manor luxury shingles, color brownstone. Supervisor Shiring moved to approve the Certificate of Appropriateness as recommended by HARB. Vice-Chairman Boorse seconded the motion which was unanimously approved.

TREASURER'S REPORT

RECOMMENDATION OF NEW FINANCIAL INSTITUTION

BB&T Trust Company bought out National Penn Bank and the transition to BB&T Trust Company was made last summer. BB&T is implementing fees for services starting in September 2017 and only offering an interest rate of .04%. Sect./Treas. Nelling obtained proposals from TruMark Financial Credit Union, Fulton Bank and TD Bank for government banking services. TD Bank offered .40% interest with fees; Fulton Bank .75% interest with fees and TruMark Financial .60% interest for checking and 1.00% interest for money market with no fees to the Township for services. The Township funds would be collateralized with a letter of credit from the Federal Home Loan Bank of Pittsburgh for funds over \$250,000. Chairman Conklin moved to authorize TruMark Financial Credit Union as a financial institution for the Township. Vice-Chairman Boorse seconded the motion which was unanimously approved. Mrs. Nelling proposed that the one escrow account at BB&T remain there.

AUTHORIZE ADVERTISING FOR BBD, LLP FOR 2017 AUDIT

Supervisor Shiring moved to authorize advertising to consider a resolution at the June 5th meeting to appoint BBD, LLP to perform the audit for 2017 for a fee of \$5,000.00. Vice-Chairman Boorse seconded the motion which was unanimously approved.

Sect./Treas. Nelling provided the Board with financial statements for the first quarter 2017.
