BIRMINGHAM TOWNSHIP BOARD OF SUPERVISORS MINUTES AUGUST 6, 2018

The regular meeting of the Board of Supervisors was called to order at 7:30 PM in the Township Building by Vice-Chairman Shiring with the pledge of allegiance. A quorum of Supervisors was declared.

Absent was Chairman Scott Boorse.

Supervisor Hill moved to approve the July 9, 2018 minutes as written. Vice-Chairman Shiring seconded the motion and the minutes were approved.

Supervisor Hill moved to approve the bills submitted for payment. General Fund bills totaled \$37,511.23. Sewer Fund bills totaled \$24,503.06. Vice-Chairman Shiring seconded the motion and the bills were approved.

POLICE REPORT

Chief Nelling reported for the month of August. There were 1,255 incidents during the month including eight criminal complaints. There were 7,108 patrol miles logged on the vehicles during the month.

At the recommendation of Chief Nelling, Vice-Chairman Shiring moved to hire Tyler DeVoe from Sadsbury as a part-time police officer at the training rate of \$19.00/hr. Supervisor Hill seconded the motion which was approved.

Chief Nelling proposed an update to the Peddling and Soliciting Ordinance (Chapter 82 of the Code) so the solicitation hours would be consistent with surrounding townships. The current hours are 8 AM – 6 PM. The new hours would be 9 AM – 9 PM. Vice-Chairman Shiring moved to authorize a hearing on the ordinance update for September 10^{th} @ 7:30 PM. Supervisor Hill seconded the motion which was approved.

BRANDYWINE CONSERVANCY MEETINGHOUSE ROAD EVENT 9.11.2018

Andrew Stewart, Director of Marketing and Communication, of the Brandywine Conservancy was present to advise the Board of an event being planned on their 113 acre property on Birmingham Road between Wylie and Meetinghouse Roads (the O'Dell tract). The event will be held on Tuesday, September 11^{th} from 10 AM - 12 PM. The purpose of the event is to commemorate the Brandywine Conservancy's purchase of Birmingham Hill, the historic site of the September 11, 1777 Battle of Brandywine. It will be a private event hosting about 200 people. The Supervisors will be invited as will officials from surrounding townships. It will be very similar to the Civil War Preservation Trust event for the 1370 Birmingham Road property. There will be a tent erected; gunfire; reenactors; two parking attendants; and a police officer at the intersection of Meetinghouse Road and Birmingham Road. Attendees will be asked to enter

the property from Birmingham Road to Meetinghouse Road. The event will be held rain or shine.

Supervisor Hill suggested that notices be sent to surrounding property owners because of the traffic that will be generated on Meetinghouse Road.

Debbie Hineman, Meetinghouse Road resident, said that Meetinghouse Road is very narrow and it is very difficult for two cars to pass on the road. She wondered if notices would only be sent to abutting property owners as all the neighbors on the road would like to know of the event. She also asked about the timing of the notices and suggested that event signs be located at each end of Meetinghouse Road.

On a separate matter, Mr. Shields informed the Board that the Brandywine Conservancy has plans to locate the entire Birmingham Hill trail on the south side of Meetinghouse Road so that it doesn't traverse the road.

MILLER/1060 W STREET ROAD ZONING HEARING BOARD APPLICATION

The Zoning Hearing Board (ZHB) will be meeting on September 19th to consider the application of William and Regina Miller for variances for driveway improvements for their property at 1060 West Street Road. Variances requested are: 1) from the 10% maximum impervious coverage requirement of Section 122-14.C of the Code to have 10.5% impervious coverage; and 2) from the 90% minimum green space requirement of Section 122-14.1 of the Code to have 89.5% green space in order to permit the driveway improvements.

Jack Wuerstle, Esq. was present representing the Millers. The throat of the driveway is proposed to be paved, which is currently compacted crushed stone. The driveway is being expanded to allow for a second vehicle to turn around in order for it to exit the property onto an existing difficult egress onto Rt. 926. The paving will continue under the overhang of the roof of the shed located on the property. Mr. Wuerstle stated that the variance request is diminimus. If the property was 370' larger in size the variance requests wouldn't be needed. Mr. Wuerstle added that the original percentages for the deviation requests from the Code presented in the application may need to be changed ever so slightly. He will have the final numbers for the ZHB hearing notice.

Vice-Chairman Shiring moved to take a non-position on the ZHB variance application for the Millers for 1060 West Street Road and to defer to the expertise of the ZHB. Supervisor Hill seconded the motion which was approved.

HOFMANN/JACOBS/1001 COUNTRY CLUB ROAD HARB AND HISTORICAL COMMISSION RECOMMENDATIONS FOR POOL RENOVATION

At its meeting on July 17th HARB recommended that a Certificate of Appropriateness be issued to Georgianne Jacobs and Steven Hoffman, 1001 Country Club Road, for the renovation of an existing pool on their property. The following steps will be taken for the renovation:

- A steel reinforced gunite concrete shell will be placed into the existing shell of the pool;
- WetEdge Pearl Matrix aggregate interior will be placed over the gunite concrete shell. The color of the WetEdge interior will be Midnight Ocean;

- One row of 6" x 6" tile will be placed around the upper perimeter of the pool at the water line. The color of the tile will be Aztec Blue;
- The coping around the pool will be Pennsylvania Bluestone;
- The pavers around the pool will be tight joint Pennsylvania Bluestone;
- The fence around the pool will be split rail with plastic coated green wire mesh which will be pool code fencing.

Supervisor Hill moved to approve the Certificate of Appropriateness as recommended by HARB for the pool renovation at 1001 Country Club Road. Vice-Chairman Shiring seconded the motion which was approved.

At its meeting on July 24th the Historical Commission (HC) recommended approval of the pool and the blue stone decking renovation for Georgianne Jacobs and Steven Hoffman, 1001 Country Club Road, HR#9 (Fernbank Stock Barn).

Supervisor Hill moved to approve the recommendation from the HC for the pool repair and blue stone decking for Georgianne Jacobs and Steven Hoffman, 1001 Country Club Road. Vice-Chairman Shiring seconded the motion which was approved.

AUTHORIZE ADVERTISING FOR SNOW REMOVAL 2018/2019 SEASON

Vice-Chairman Shiring moved to authorize advertising for bids for snow removal services for the 2018/2019 season with bids to be received by 2 PM on Monday, September 10th for review at the Township meeting that night. Supervisor Hill seconded the motion which was approved.

AUTHORIZE ADVERTISING FOR BBD, LLP FOR 2018 AUDIT

Vice-Chairman Shiring moved to authorize advertising for the consideration of a resolution at the September 10th Township meeting to appoint the accounting firm of BBD, LLP, to examine the Township accounts for 2018 and to prepare a report for the Supervisors. The fee for the service will be \$5,000.00. Supervisor Hill seconded the motion which was carried.

OTHER BUSINESS

Vice-Chairman Shiring stated that prior to tonight's meeting the Supervisors met in executive session with the Township Engineer, Jim Hatfield with VanDemark & Lynch, Inc. The National Fish & Wildlife Foundation has awarded funds to the Brandywine Conservancy to conduct a feasibility assessment and identify opportunities for improving stormwater management in the Plum Rum watershed. Plum Run traverses through a small corner of the Township to the Brandywine River. All townships in the watershed are asked to participate in the collaborative effort. Vice-Chairman Shiring moved to authorize the Township Engineer, Jim Hatfield, to attend the initial meetings with the Brandywine Conservancy on improving the stormwater management for the Plum Run watershed. Supervisor Hill seconded the motion which was approved.
