BIRMINGHAM TOWNSHIP BOARD OF SUPERVISORS MINUTES JANUARY 3, 2022 REGULAR MEETING

The regular meeting of the Board of Supervisors was called to order immediately following the organizational meeting. A quorum of Supervisors was declared.

Scott Boorse - Chairman
Michael Shiring - Vice-Chairman
J. Daniel Hill - Supervisor

Vice-Chairman Shiring moved to approve the special meeting minutes from December 6, 2021 on the Historical Commission Ordinance and the regular meeting of the Board of Supervisors held on December 6, 2021. Supervisor Hill seconded the motion and the minutes were unanimously approved.

Vice-Chairman Shiring moved to approve the bills submitted for payment since the December 6, 2021 Meeting. General Fund bills totaled \$64,864.60. Sewer Fund bills totaled \$160.00. Chairman Boorse seconded the motion and the bills were unanimously approved.

PUBLIC COMMENT

There was no public comment.

VMDT PARTERSHIP/JAGUAR ZONING HEARING BOARD (ZHB) APPLICATION FOR SIGNAGE @ 1330 WILMINGTON PIKE

Rich Orlow, Esq., CPA, was present on behalf of VMDT Partnership. A hearing will be held on January 19, 2022 before the ZHB for an interpretation that multiple wall signs are permitted for the automobile dealership use and, in the alternative, variances from Section 122-90.B(2) to permit multiple wall signs on the building's frontage and to permit multiple wall signs on the building's side walls for the automobile dealership use.

Mr. Orlow explained that the ordinance does not allow for signs on the non-street side of buildings. The signs being requested are "Jaguar"; "Land Rover"; "West Chester" and "Service". The Jaguar and Land Rover signs are multiple uses within a single building and therefore should be interpreted as a use by right, but if not, a variance is requested for both. The "West Chester" and "Service" signs are being requested by variance for the sales and service identifications for the automobile business.

Mr. Orlow stated that the total square footage for all the signs is 109.69 sq. ft. which meets the ordinance requirement of 122.25 sq. ft.

Mr. Orlow said that a variance is also being requested for the names "Jaguar and its logo" and "Land Rover and its logo" on the southern and northern elevation walls which have no frontage on a street as required by ordinance.

Mr. Orlow commented that he has met with the Township Engineer, Dave Schlott with Arro, regarding ground signage but that is not part of this application. The signage located at the West Chester Pike location has been installed temporarily at the Wilmington Pike location.

Vice-Chairman Shiring moved to take a non-position on the application and to defer to the expertise of the ZHB to render a decision after hearing the testimony. Supervisor Hill seconded the motion which was unanimously approved.

AUTHORIZE ADVERTISING ON STORM PIPE VIDEO INSPECTION BIDS

Chairman Boorse moved to authorize advertising to televise the storm pipe inlets in the Birmingham Hunt and Knolls of Birmingham Subdivisions and on General Lafayette Blvd. with the bids separated out into three alternates, one for each location, as well as a total bid for all three locations. The bids will be advertised on January 11th and 18th and available on PennBid until February 2nd with the bid to be considered for award at the February 7th meeting. Vice-Chairman Shiring seconded the motion which was unanimously approved.

DISCUSSION OF HISTORICAL COMMISSION ORDINANCE

A special meeting to review provisions of the Historical Commission (HC) Ordinance of the Township Code, specifically Article VIIIA Historic Preservation, Section 122-36, was held on December 6, 2021 and continued until tonight following the regular meeting. The purpose of the review is to streamline the review process and identify inconsistencies in the ordinance.

The review continued with discussion of Section 8. (Section 122-36.4, titled, "Demolition of Historic Resources". Some suggestions made included:

- Removal of alterations and modifications which are handled in another section and just have this section address demolitions.
- Paragraph B delete Class I, II and III historic resource reference and capitalize Historic Resource.
- Paragraph B removes significant interior revisions that require building permits and only building permits that have a structural element to the application; that affect load bearing walls, would come to the Supervisors for review. Alterations and modifications would be removed from the HC's purview.
- Notification requirements to neighbors reduced from 500' to 200' and certified mail notifications changed to the property being posted seven days prior to the meeting.
- Elimination of time frame requirements.

Suggestions made during the discussion of Section 10 (Section 122-36.6, titled, "Landscaping and Screening" included:

- Elimination of landscaping and screening review by the HC and only as part of the subdivision and land development review process.
- New building setback of 50' for that is bordering a tract of land that is the Historic Resource and 100' for a new building from an Historic Resource
- Move Section D to A so the architect knows what they are looking for in preparing a landscape plan.

Suggestions made during the discussion of Section 11 (Section 122-36.7, titled "Changes to Historical Resources" include:

- Discussion of addition versus alteration with an addition being a change to the footprint with an increase in floor area or height. The footprint doesn't change in an alteration.
- Addition excludes decks
- In Section H the standards should match those applicable for the National Register to provide guidelines to the applicant

Section 12 (Section 122-36.8 titled "Historic Resource Impact Study): is deleted for minor subdivisions and land development plans and is only applicable for major subdivisions and land development plans unless waived, or modified by the Board of Supervisors. Solicitor Camp felt the studies were expensive to do and didn't provide any additional help in rendering a decision.

Solicitor Camp will update the ordinance per the input from the two meetings for review and further comment by the Supervisors.

The meeting was adjourned at 8:50 PM. (SCB:JDH)
