CONSENT BY OWNER, LESSEE OR USER

As provided in Section 1600.1 of the Automatic Protection Devices Ordinance (99-02) of Birmingham Township, Chester County, the undersigned, user, lessee or owner of the alarm system located at the premises indicated on the reverse side hereof, hereby agrees, as a condition to installation and/or continued operation of such equipment or service, to pay Birmingham Township for all false alarms originating from the indicated premises as follows:

First false alarm in a calendar year – warning

Second false alarm in a calendar year and thereafter - \$25.00 each alarm

Further if this is a medical alarm, the owner, lessee or user hereby agrees that this application/permit shall constitute a waiver by such person of the right to bring or file any action, claim or complaint whatsoever against any police officer, Birmingham Township, or emergency medical personnel who make or makes a forced entry in response to such alarm into the premises on which such an alarm is installed. In the event the owner of such premises is a person other than the permit applicant, as in the instance of a lessee or other user not the owner of the premises on which the alarm is installed, this applicant/permit shall constitute an indemnification agreement by the applicant to hold harmless any such police officer or medical emergency personnel from any and all damages whatsoever claimed by the lessor or owner of the premises on which the alarm is installed.

The undersigned applicant also agrees that this application for a permit for the installation of an alarm system and subsequent installation of such a system pursuant to a permit issued or the continuance of the installation and/or operation of any alarm system already installed at the time of said application shall constitute consent by the owner or lessee thereof and the authorization for the inspection of any such installation and/or operation by the Chief of Police or any other designated agent of the Township. All such entries upon the premises which an alarm is installed and all such inspections of the installations and operation of alarm systems shall be at reasonable times and upon reasonable notice, except in emergency situations.
