The Trust helped with maintenance tasks at Sandy Hollow last year and their assistance was very much appreciated by RPOS.

Mr. Socash also said that there is a tree leaning badly at Birmingham Hill. Mr. Feld said he will take a look at the tree. Mr. Feld also said that there are posts stored in the barn on the former O'Dell property that could be used along the fence at Birmingham Hill.
