##### **245th Reenactment Sept 24-25**

There will be a meeting to discuss the reenactment at the Birmingham Township building on March 9 at 7:00 PM. The RPOS Committee will run the Township tent during the event.

#### **APPROVAL OF AGENDA**

## **Sandy Hollow**

1. Deerfield gave a price to clean up the hedgerow and tree vines. Since RPOS is saving on the landscape budget, Mr. Feld would like to spend the difference on that effort. Mr. Socash motioned to approve using the budget towards Deerfield's clean-up. Mr. Bonkoski seconded; all in favor.

## **New Business**

1. Ms. Doreen O'Neill attended tonight's meeting as she is interested in joining the Committee. She is currently available to devote her extra time to RPOS efforts, has a financial background, and has lived in the Township since 1993. Mr. Socash motioned to recommend that Ms. O'Neill join the RPOS Committee. Ms. Brecker seconded; all in favor.
2. North American Land Trust acquired Brinton Run Reserve on Oakland Road. They plan to put trails there this Spring. They would like permission to use Birmingham Township's sign wording, Brandywine Battlefield Trail, and symbol, as there may be connecting trails through Birmingham in the future.
3. RPOS discussed needing volunteers for different events and work days. The idea of creating a social media account to create and share posts was brought up as a possibility. Ms. O'Neill added that she was unaware of these days in the past, so members agreed that a social media post or something similar would be an efficient way to spread the word.

Mr. Socash motioned to adjourn the meeting. Ms. Brecker seconded; all in favor. With no further business and with no public comment, the meeting was adjourned at 7:23 PM.
