#### Right of Way

The Conservancy recently ground two large maple stumps on Meetinghouse Road. Ms. Brecker and Mr. Feld volunteered to clean up the leftover debris.

# **Sandy Hollow Update**

### **Dog Waste Stations**

Since the trash overflow incident, the dog waste stations have remained clean so RPOS is confident it was most likely a one-time occurrence.

#### Reenactment

As of today, there are not enough volunteers during the week to help with setting up the sites and safety line.

Mr. Feld was able to secure a straw donation from Jamie Hicks.

Volunteer Parking will be located across the road in the field by the Knolls. There's a meeting for volunteers working the day of the event Wednesday night at 6:30pm.

#### **Budget**

The 2023 RPOS budget needs to be prepared for the budget meeting on October 12th. RPOS is allotted \$26,000 for both trails.

Mr. Feld raised the proposed budget for Birmingham Hill landscape maintenance to compensate for price increases, added \$800 for a new bench, and \$400 for replacing flags. Members agree the tree maintenance budget should be raised as well.

Mr. Feld suggested someone look at the signs at Sandy Hollow and Birmingham Hill to see if it would make sense to switch them around. Mr. Bonkoski volunteered to check next time he's nearby.
